

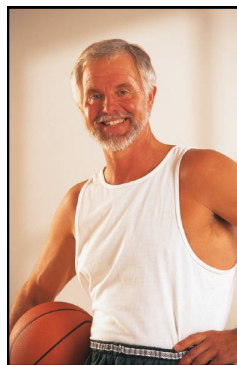

### **Registration**

Registration: First come, first serve basis, until program is filled. A waiting list will be generated for all persons who register after class is full. Partial payments are not accepted. Special requests may not be granted or guaranteed. Registration must be received by 5:00 pm the Last Thursday prior to the following month. Late payments will be accepted with a \$10 service fee per person.

### **Payments**

Payments by check, money order, Visa or MasterCard only. A collection fee will be charged for each check returned by the bank. No partial payments accepted. **Make check payable to: L.A. City Department of Recreation and Parks.**

### **Refund Policy**

Refunds will be subjected to a 15% administration fee. No refunds will be approved after a session has begun. No credit or refunds will be approved for missed or partial days. For refund requests due to a medical emergency or related reason; a letter from the treating physician will be required for consideration of refund request. Late payments are non-refundable.

Persons with disabilities are welcome participate in our programs. Reasonable accommodations may be made with prior arrangements.

**Refund Policy:** NO REFUNDS will be approved or issued after the first class date. NO CREDIT or PRORATING of fees will be approved for partial or missed class dates. NO FULL REFUNDS will be approved or issued unless the program is canceled by the City of Los Angeles, Department of Recreation and Parks, Peck Park Community Recreation Center. Any refund approved will be accessed an administrative fee of 15%.

### Hold Harmless Waiver Clause:
