### LEAGUE COST

**7 v 7 League Fee: \$250 Bond: \$50      11 v 11 League Fee: \$350 Bond: \$240**

- All fees must be paid at time of registration. Make checks or money orders payable to: **City of Los Angeles**. Visa & Mastercard credit and debit cards are also accepted.
- **\*Affiliation requires an additional \$22.50 per player fee paid directly to Cal South Soccer.\***
- *Only completed applications with full payment of fees will be accepted.*
- Teams that owe a balance from the previous season must pay before registering, including **any/all red cards and fines**.
- Teams that already have a complete Forfeit Bond on file with the League will not be required to submit a new bond. Please note that at the conclusion of the league, Forfeit Bond shall remain in the Team's League File for usage in future leagues. It is the responsibility of the Team Manager to request that their Forfeit Bond be refunded in writing (if desired). Forfeit Bond will be forfeited if team is dormant from league for 3 consecutive years.
- **OFFICIALS' FEE IS TO BE PAID IN CASH ON THE FIELD PRIOR TO START OF EACH GAME.**  
**FAILURE TO COMPLY WILL RESULT IN FORFEITURE OF GAME.** Note: 11 v 11 Fee for 3 officials will be \$60.00. In the event that only 1 official works the game, Officials' Fee shall be \$40.00. Officials' fee for 7 v 7 is \$25.00.

### OTHER INFORMATION

- **League is projected to start the week of March 11, 2012.** Space is limited, so sign-up early!
- League Administration has the right to place teams into different divisions.
- There will be approximately 10 games. Rained out games are not guaranteed to be made up. As for the past several years, we will not be offering "Friendly Games".
- All players will need to sign the Team Roster with the "Release of Liability" waiver before participating in the league.
- All players must be 18 years of age or older at the time of registration.
- All players must be registered with Cal South and have a player's ID card to be eligible for the league.

## FORFEIT BOND

- The Forfeit Bond is refundable at the end of league play upon written request from the individual who paid the bond.
- All or part of the bond may be forfeited for any of the following reasons:
  - A) Dropping out of the league;
  - B) Unsportsmanlike conduct (i.e. fighting, intoxication, use of obscene language, etc.);
  - C) Failure on the part of any player or manager to abide by Official's decision;
  - D) Failure of team to be active for a three-year period;
  - E) Playing of any ineligible player.
- Mandatory bond balance allowed for 11v11 Forfeit Bond is \$240.00 and for 7v7 is \$50.00.

## MUNICIPAL SPORTS

The primary purpose of adult sports programs is to offer each resident of our city the opportunity to pursue, through competitive sports, the physical and emotional benefits such activity offers. All too often the emphasis in such participation has been placed on winning at any cost.

It should be remembered that in every competitive sports activity there are winners and losers. The purpose of this Code of Conduct, applicable to every participant, is to engender and motivate a return to good sportsmanship, proper conduct on and off the field, and full compliance with the rules and policies of the L.A. City Municipal Sports Section. Every individual and team participating has adequate recourse through established procedures in the filing of complaints or protests.

Effective immediately, the Code of Conduct, as defined below, is in force. Team managers will carefully review the rules and requirements herewith set forth and will make them known to their players. They are solely responsible for actions of their team(s) and players on and off the field. Improper behavior on the part of any participant can directly affect the future participation by the entire team. Be reminded that all team members, including coaches/managers, are NOT to: consume alcoholic beverages or smoke at or around game facilities, nor shall they dress, undress or urinate in public. **Penalty:** Immediate suspension and loss of tournament fees.

## CODE OF CONDUCT

The Participant's Code of Conduct applies to all players, coaches and managers. This code applies to players as individuals and as a team, and the penalties can be applied to an individual and/or an entire team. This code becomes effective as soon as the participants arrive at the facility of play and remains in effect until the participants leave the facility.

- A. No Participant shall:**
  1. At any time lay hand(s) upon, push, shove, strike or threaten to strike an official;
  2. Be guilty of a physical attack as an aggressor upon any player, official or spectator;
  3. Endanger the safety of any player, coach, manager, official or spectator.
- B. No Participant shall:**
  1. Refuse to abide by an official's decision;
  2. Be guilty of heaping personal, verbal abuse upon any official for any real or imaginary wrong decision or judgment;
  3. Be guilty of using unnecessarily rough tactics in the play of the game against an opposing player.
- C. No Participant shall:**
  1. Be guilty of objectionable demonstrations of dissent at an official's decision by throwing equipment or any other forceful action;
  2. Discuss with an official in any manner the decision reached by such official (except Manager).
- D. No Participant shall:**
  1. Smoke while going on or coming off the facility, or while on the field of play;
  2. Be guilty of discussing publicly with spectators, in a derogatory manner, any play or decision, or personal opinion of other players/officials during the game (NO trash talk);
  3. Appear on/at the facility at any time in an intoxicated condition, or consume any alcoholic beverage while on a recreation facility.
- E. All players must sign the Player Release of Liability and Registration Form prior to participation, or be subject to game forfeiture or disqualification.**

**NOTE:** We are mandating that officials report any participant that is difficult or that refuses to abide by our league's motto of friendly competition. Please, **NO PROFANITY!** We are committed to making our leagues the best they can be. Particular attention will be paid to player conduct and excessive contact.
